PURPOSE

This comprehensive course uses a variety of aquatic therapy principles from NDT (Neurodevelopmental Treatment/Bobath) perspective to address the skills that support functional communication.

PROCEDURE

This course begins with an introductory lecture with videos and NDT lab participation, followed by demonstration and practice learning the principles of aquatic therapy including treating and being treated in water. Presenters will demonstrate with clients; participants will experience the therapy process with each other and clients. Active group problem solving techniques will be used to identify clients' needs and develop functional goals and objectives for remediation.

OBJECTIVES - PARTICIPANTS WIL:

- Discuss and use components of water for therapy (buoyancy, respiration, movement)
- Acquire competency in identifying and assessing clients for aquatic therapy
- Treat a variety of clients in water
- Discuss when to use water and when to use land options
- Describe carry over strategies from aquatic setting treatment to functional clinic tasks
- Describe a treatment plan for a client

Certified in NDT (NeuroDevelopmental Treatment/Bobath), Hendricks Institute Radiance Breathwork and Prenatal Process, she is also a WATSU Practitioner and member of Worldwide Aquatic Bodywork Association (WABA). Susan works in water heated at or near body temperature (93 -96°F) so that clients feel neither chilled nor overheated enabling them to attain goals being addressed.

Susan has a private practice in Garberville, Ca., USA, where she serves a varied population ranging in ages from infant through geriatric.

Susan has taught classes in Assessment and Intervention of pediatric oral motor development and feeding issues for Busy Bodies Pediatric Seminars and provides in-service and consultation to colleagues in area of feeding, oral-motor development, respiration/phonation, discrete trial programs and other related issues. She treats clients, infants – geriatrics, with a variety of speech language disorders. She has taught classes to colleagues addressing issues in voicing, feeding, swallowing, speech and language including Autism Spectrum Disorders, stroke, cerebral palsy, Down syndrome, etc.
